Dear Mr Medd

I am appealing to you for help in this matter as Leader of Fenland District Council and as such I feel that you should be made aware of the certain inappropriate behaviour of a member of your Council.

For a number of years now and certainly commencing in 2009 I have been at the receiving end of inappropriate and intimidating behaviour and the unpleasant actions of David Connor. This man moved into the house next door to me in 2009 and in January 2010 told me that our boundary line was not correct and that my Land Registry Plan was incorrect. In April 2010 I was forced to take serious action because David Connor was forcefully attempting to steal some of my land by sending Youths with their faces covered, to hammer fence posts into my land thereby fencing off from me, land which I legally owned. This was a very frightening situation for me as I was alone and vulnerable. I contacted the District Council Solicitor by telephone as David Connor had told me, in a confrontational situation, that he had managed to get onto the Council and that he was particularly interested in the Planning Committee because he wanted the 'Power' it would give him. At that time I had submitted through a local and reputable Planning Consultant, an application for permission on a piece of development land which I own and which adjoins Mr Connor's property. I had previously turned David Connor down when he told me (suggesting no choice in the matter) that he would buy my land.

The Council Solicitor told me that the District Council has no control over the personal behaviour of any District Councillor in relation to their personal life, but that he would have a personal word with Mr Connor that week as he was seeing him anyway in relation to his appointment.

My Planning application was eventually granted with no intervention from David Connor as he apparently had to undergo some training for the Planning Committee, so was unable to involve himself in my Application.

Subsequently his intimidating behaviour escalated and I had no other choice, so I took my case to the District Judge in Peterborough as David Connor was constantly parking his very big vehicle which is a 4x4 Black Navara immediately outside my front entranceway. I have photographs which I had to take for my Court Case showing his vehicle 18 inches from my front porch entrance. There were several times when I had to ask him to move his vehicle so that I could have a delivery or removal of furniture from my home. His Barrister's Defence Statement disclosed that he had an unhealthy knowledge of my movements in relation to when I was or was not at home. His unhealthy attentions made me feel that I was no longer safe in my own home so I spent long stays at my Daughter's and my Mother's homes as a result.

When the case was heard by District Judge Chaudhuri on 20 May 2013 (Claim No 3PE00193) the Boundaries were determined in accordance with my Title Plan and I was given the right to remove fencing erected by David Connor and replace it with my own in the position determined by my Land Registry Plan and Judge Chaudhuri.

Unfortunately this was not to be the end of the feud.

In June 2013 I submitted a Pre-application to Fenland District Council for Part-Change of use on my very large 20 room house to a Children's Day Nursery. My house had been on the market for 3 years at considerably less than what it had cost me (including renovation work) but I was unsuccessful in selling so I had to find an alternative. I have previously built up and run three very successful Childrens Day Nurseries in Huntingdon but due to a cancer scare in 2002 was forced to sell. I felt that The Hermitage, with its design layout, it's size and it's location was ideal for this purpose and I wanted to repeat my past success as my job prospects were null and void having been 'made redundant' from running The South Fens Business Centre at Chatteris.

The Application was handled by Peter Humphrey Associates Wisbech and the end Date for decision on the actual Application was originally dated 4 November 2013. To date a decision has still not been made.

I was advised at a meeting at Fenland Hall on 3 December with Graham Nourse, Alison Callaby and Kathryn Brand that my application was being forwarded for approval on a delegated decision. I have emails to prove that this was the case. I also have emails to prove that the paperwork relating thereto was being prepared for week commencing 6 January 2014. However there has suddenly been a complete turn-around and the case has now been listed to go before the Planning Committee.

In 2006 I was involved in the development of Fenland District Council's diagrammatic representations of the Processes within all the Service departments for use by Staff within the One Stop Shops. I am the author of several of those processes and I am therefore familiar with them.

What has now happened with my Application does not conform to process and is illogical.

I have now discovered that there has been some considerable intervention by David Connor during the period between 1 January and 6/7 January.

It appears that David Connor is using his position as a Fenland District Councillor and Vice Chairman of The Planning Committee as well as his position as a Cambridgeshire County Councillor to rally opponents against my application for a change of use to Nursery.

I would like to know who has given David Connor the dispensation to use his position as a District Councillor and a County Councillor to lead or rally an opposition party against my Planning Application.

I would like to know under what authority this has been granted considering that he clearly has a personal interest in my Planning Application and also considering that this man is using his position in such a way that is contrary to the Power granted to him, and he is clearly attempting to head a personal vendetta against me.

I hold a considerable amount of evidence in the form of Court Papers, Documents, Photographs and Police Incident Numbers.

I also have copies of derogatory statements that David Connor has made on social networks such as Twitter and a Newspaper article resulting from an Interview he gave, that was posted on the Internet but which I was able to stop from going to Print. I also hold a threatening letter that was sent to me by David Connor signed in his capacity as a Fenland District Councillor and a Cambridgeshire County Councillor.

All of which are available for scrutiny.

District Councillors and County Councillors are supposed to follow the Council's ethical and other codes of conduct at all times with honesty and integrity. They should be there to represent the people within our Community. To understand and listen to the views of ordinary people going about their daily and working lives.

They are not meant to use their powers in such a way that is self-gratifying and for their own personal gain or satisfaction and certainly not to intimidate and worry people living locally within their own community.

This, David Connor has done to me and it is not morally or ethically right. Please intervene and put a stop to this matter.

CODE 1 CODE OF CONDUCT FOR MEMBERS

Part 1

General Provision

.....

- (5) Where you act as a representative of your authority –
- (a) or another relevant authority, you must, when acting for that other authority, comply with that other authority's code of conduct; or
- (b) On any other body, you must, when acting for that other body, **comply with your authority's code of conduct**, except and insofar as it conflicts with any other lawful obligations to which that other body may be subject.....

General Obligations

- . (1) **You must treat others with respect.**
- (2) **You must not -**
- (a) **do anything which may cause your authority to breach any of the equality enactments (as defined in section 33 of the Equality Act 2006);**
- (b) **bully any person;**
- (c) **intimidate or attempt to intimidate any person who is or is likely to be-**
- (i) a complainant,**
- (ii) a witness, or**
- (iii) involved in the administration of any investigation or proceedings,**

10. (1) Subject to sub-paragraph (2), where you have a personal interest in any business of your authority you also have a prejudicial interest in that business where the interest is one which a member of the public with knowledge of the relevant facts would reasonably regard as so significant that it is likely to prejudice your judgement of the public interest.

CODE 2 LOCAL CODE OF CONDUCT ON PLANNING MATTERS

Lobbying

1. In most cases it should be possible for a member to listen to a particular body of opinion, without engaging in lobbying for a particular outcome, and wait until the Planning Committee, to hear all the evidence presented, before making a final decision.

.....

- **should not express an opinion which may be taken as indicating that they have already made up their mind on the issue before they have considered all the evidence and arguments;**

.....

- **should not openly declare which way they intend to vote in advance of the relevant Committee meeting, or otherwise state a commitment to oppose.**

.....

Members who have openly declared their voting intention (on a planning or any other application, enforcement case or Local Development Framework proposal) **in advance of the relevant Committee meeting** should declare their interest and not vote because they could be considered to have fettered their discretion. In those circumstances a member should not speak and vote as a member of the Planning Committee. In such cases the member has been excluded not because of the code but because the member's previous actions have fettered his/her discretion and **possibly laid the Council open to the objection that the planning process has been tainted.**

To avoid impressions of improper influence which lobbying by members can create:

- **Members should avoid organising support for or opposition to a planning matter to be determined by the District Council, and should not lobby members of the Planning Committee - such actions can easily be misunderstood by parties to the application and by the general public;**

- **Members should not put pressure on officers for a particular recommendation;**

26. There is much case law on what are, and are not material planning matters.

Planning matters must relate to the use and development of land. For example, the following are not normally planning matters and cannot be taken into account in planning decisions:

- **the fear that an objector's house or property might be devalued;**

27. **The principles of this Code also apply to press contact. Members and officers when commenting to the media on planning matters should:**

- **have regard to the points made in the section on lobbying;**
- **ensure that they do not give the -impression that they have pre-judged the planning application;**
- **make clear that members will retain an open mind until such time as the full facts are available and these are debated by the appropriate Committee;**

Reference fence that Mrs Oswald erected at the side of our property.

We arrived back from our summer holiday to see that whilst we had been out of the country extra fence panels had been erected on the Oswald's side of the boundary which breached planning regulations as they measure almost 8 ft. high blocking our light in the kitchen as a result making it very dark. I spoke verbally to Mr Bill Tilley Fenland District Councils enforcement officer regarding this matter and he advised me to have a word with the Oswald's regarding this. I told Mr Tilley this wasn't really advisable as re all the problems we had, had in the past. He then advised that I write them a letter requesting that they remove the fence or reduce it to the correct height, giving those involved 14 days to reply to this request. It was a pleasant letter not in any way threatening at all. With regards to my signing of the letter I am David Connor, I am a FDC & a CC voted in by the public which Mrs Oswald knows only too well as she posted her vote at Doddington village hall where I was on polling day. She also had two extremely large posters attached to her property in support of UKIP which she is fully entitled to do, I had no problem with this at all. I spoke with Mr Tilley after the 14 days had expired & informed him that I received no correspondence back from the Oswald's and I asked him to investigate in his position as an officer at FDC and myself as a next door neighbour. After a couple of days Mr Tilley advised me via phone that he could do nothing re the fence as it was in part an application for a 60 bed nursery. This was my first knowledge of the pending application for this nursery.

Reference letter from Mrs Diane Oswald to Mr Paul Medd.

- Boundary dispute – the actual facts were my X wife's son & his friend age 12 approx were riding a motocross bike on my land at the bottom of the garden, she complained & I banned them from using the bike immediately & this bike is still in my shed some 4 years since. They were just being typical youngsters
- The second paragraph (POWER)- regarding being on the planning committee is total nonsense and fabrication of the truth, the discussion was about my dog barking and Mrs Oswald advised me to get an electric collar as it would give him a shock when he barked. When I refused this request she likened me to a character like The Al Capone of Doddington and told me that everyone was frightened of me. I couldn't believe this comment as all I said was, no I didn't want my lovely dog to have the experience of a collar that gave him a nasty shock, I couldn't believe what I was hearing as having just won a landslide victory in the local elections by the votes of the people of Doddington.
The solicitor Mr Ian Hunt did certainly speak with me after a planning meeting & advised me to keep well away from Mrs Oswald.
- Planning Permission re 4 plots – Mrs Oswald states that planning permission was granted on the 4 plots with no intervention from me because I was on training for planning, but does she not realise that I could have spoken against this application as a resident (next door neighbour) for 5 minutes had I have wanted, I didn't!
- Car in front of her entrance to front door - did park my car near to her front entrance but nothing like 18 inches over her entrance. I admit to it probably being laziness on my part not parking further away, however, when requested I moved it immediately without any confrontation.
- Judge statements (thrown out! like the rest of it was) and can be proven by our solicitors who attended the court hearing (this she has failed to tell you!)
Mrs Oswald spoke to me telling me that she had to get away from Mr Oswald because of his lack of respect for her two children, Matt & Becky and that she had a job in Cornwall to go to for at least 6 months, she also stated that he had nothing to do with any of his own children and was trying to drive a wedge between herself and her siblings. She also told me that her daughter Becky & her partner were moving into the house (next door) and asked me to keep this secret as Mr Oswald would go mad & take her to court for the monies that she owed to him for the renovation of the house. I was surprised at this but kept this a secret until now some 4 years on.
- The boundary – the boundary between our properties is not clear and Geoff Taylor (building consultant) has confirmed this from years past, saying – it has a wobbly boundary. PJ Coles put a fence up and it is 2 inches over her boundary in the middle of the fence because of a self-set tree. The fencing contractors were verbally abused by the Oswald's whilst erecting this fence. On the day that the fence was erected my X wife's father, who was staying with us at the time, had a brain seizure & an ambulance was called to revive him, he unfortunately died the same evening at Hinchinbrook Hospital.

Whilst the ambulance was outside they were still arguing with the contractors so I went outside and asked them to leave it today as we had an emergency within the family, they refused to leave it and the contractor's left. What a total lack of respect from the Oswald's for human life.

- Renovation of Mrs Oswald's Property – In my opinion wasn't up to standard e.g. wiring. Old wiring left in the walls, new switches on the outside, old boiler, expensive to run. In the early part of 2010 the Oswald's used to come into my house to share wine & nibbles & to keep warm.
- This Application for change of use - In my opinion this application is seriously flawed, as residents we were not fully informed of the application from my research and from Mrs Oswald's notes to yourself and her emails to yourself backing this up May I add. It certainly appears that behind the scenes on 3rd Dec 2013 Mrs Oswald was advised that this application was being forwarded for approval on a delegated decision. So why were we given a revised application for a 40 bed nursery some 14 days after it was up for approval then we had 14 days to submit our comments over the Christmas & New Year period, may I add! The parish council couldn't meet over this Christmas period and indeed were not even consulted on this new application so it came to my attention that the Parish Council Chairlady and committee members had to make their own comments via letters or email. So by early January you had received 12 letters of objection 8 of which are from immediate near neighbours to this proposed application. Due to your lack of correspondence and also the time scale and not being able to get a fellow councillor to call this application to the planning committee.
- In relation to the comment (considerable intervention by David Connor between the period 6/7 Jan 14) you will see from my previous comments that I had little choice in this matter as in my view the application was being pushed through without due consideration to my neighbours, parish council and myself. It is unfortunate that on this occasion with a proposal that involves me as a next door neighbour, my position as a FDC & County Councillor is criticized when I take no expenses at all! I was in all of these positions before this application was ever considered. I just wonder if Mrs Oswald is using her position to get maximum support for this application using me and my position on the council as a lever to gain support.
- Actually I have spoken with Matthew Holden (Mrs Oswald's son) who lives in the premises twice recently and have urged him to speak with his mother re getting in touch with me regarding the application but nothing has come of this from the Oswalds.


