2.2 The Chief Finance OfficerEach of the Corporate Directors-will deputise for the Chief

Executive in his/her absence on a monthly rotating basis. Members will be provided with a copy of the rota for reference.

Change 3 - to update this section due to changes in legislation.

2. Conduct of Cabinet Meetings
2.1 Chairman

If the Leader is present, he/she shall preside at meetings of the Cabinet. In the absence of the Leader, the Deputy Leader will chair the meeting. If the Leader and Deputy Leader are not present, Cabinet will appoint a person from among those present to preside at the meeting.

Change 7 - to update the constitution in line with previous constitutional changes to allow the Chairman of Corporate Governance to come from any member of the Committee.

10 Corporate Governance Procedure Rules
4. Membership of the Corporate Governance Committee
4.1 There shall be a maximum of 9 members of the Council on the Corporate Governance committee with seats allocated to political groups in proportion to the number of seats held by each group on the Council as a whole. Up to three members from Cabinet and three members of the Overview and Scrutiny Panel may be members., but neither of these may Chair the Gorporate Governance Committee.
