<b>CMT Officer:</b> Carol Pilson, Corporate Director and Monitoring Officer	<b>Delegated Power Being Exercised:</b> Delegated authority provided by Council on 15 September 2025 (C32/25)  “To approve the delegation of the procurement of these vehicles to the corporate director with responsibility for Environmental Services, through existing procurement frameworks or mini tender as required, in consultation with the Portfolio Holder responsible for street sweeping, recycling and refuse collection.”
<b>Subject of Decision:</b> Purchase of two Refuse Freighters at 26-tonnes and 18-tonnes respectively	

<b>Decision to be Taken:</b> The Portfolio Holder is requested to agree the or order (and thus purchase) of a 26-tonne refuse freighter and 12 Tonne refuse freighter via the RECAP Vehicle Framework for work within the Garden Waste service.  It is expected that the vehicles will be £388,000 in total; with capital budget agreed by Council for 2026/2027.  The vehicles being replaced are between 10 and 15 years old and will be sold or scrapped, with a current frontline vehicle moving to ensure that we continue to have a suitable level of spare vehicles.  <b>Decision:</b> To purchase a suitable 26 Tonne and 12 Tonne refuse collection vehicle via the current RECAP Vehicle Replacement Framework, with payment upon delivery in 2026/2027.
<b>Reason for the Decision:</b> These are vehicle purchases within the Fleet Forward Plan as approved by Cabinet and Council on 15 September 2025.
<b>Alternative Options Considered (if appropriate):</b> N/A
<b>Background/Reports/Information considered and attached:</b> Recap tendered for a shared vehicle purchase framework in 2022 and as a part to this Fenland benefits from the scale of vehicle purchases across the Cambridgeshire and Peterborough Waste Partnership area.
