## Statement of the Adoption of the Resource Use and Renewable Energy Supplementary Planning Document

Notice is hereby given, in accordance with regulations 11 and 14 of the Town and Country Planning (Local Planning) (England) Regulations 2012, that Fenland District Council adopted the Resource Use and Renewable Energy Supplementary Planning Document (SPD) under the provisions of section 23 of the Planning and Compulsory Purchase Act 2004 on 24 July 2014.

The SPD has been prepared to provide further guidance in relation to Part A of Policy LP14 'Responding to Climate Change and Managing the Risk of Flooding in Fenland' of the Fenland Local Plan 2014. The SPD will help developers in preparing planning applications for submission to Fenland District Council and help the Council in determining relevant planning applications.

The adopted version of the Resource Use and Renewable Energy SPD includes modifications made to the June 2014 Consultation Draft version of the SPD by the Council in light of representations received during the June consultation, and other minor changes which, taken together, do not materially affect the policies. All the modifications made since the publication of the June 2014 Consultation Version of the SPD are included in the Statement of Public Participation which is available to view on the Council's website and at the locations listed below.
