NOTES

- (i) The dedicated electricity supply on Fenland Market Places is available to all stalls that wish to connect to it, subject to the approval of the Duty Market Officer and Health & Safety best practice. All cables must be in good order, have shower proof connections and be covered to the required safety standard to remove potential trip hazards in the interest of public safety. **No heating apparatus may be used at any time.**
- (ii) Stalls are not currently provided on any Fenland Community Market and where a trailer forms the serving area or part thereof, the pitch charge levied includes the trailer drawbar.
- (iii) Monthly Market toll charges include a 6.5% discount if paid by Standing Order **for the whole year** (payable over 10 months 1st April 1st January). There is no discount given for any cash or cheque payments made.
- (iv) In addition to Market byelaws and Regulations there is a Market Towns 'Code of Conduct' and the 'Fenland Shoppers Charter' that all traders on Fenland Markets that must comply with. (Please ask for a copy).

Market Towns Service Code of Conduct - A Brief Summary

Fenland District Council Byelaws made under Section 60 of the Food Act 1984 by the Fenland District Council with respect to Markets.



Market Byelaws made by Fenland District Council in exercise of their powers under Section 60 of the Food Act, 1984, with respect to the retail general markets at Chatteris, March and Whittlesey.

Details of the Fenland District Council Market Byelaws

- In these byelaws except where the context otherwise requires:-
 - "the Council" means the Fenland District Council
 - "goods' includes provisions, commodities and articles brought into the Market for the purpose of sale;.
 - "market hours" means the hours appointed by the Council for the holding of a market;
 - "Market Officer" means the person appointed by the Council to exercise general management, supervision and control of the market place or his duly authorised representative;
 - "Market Place" means the areas of the market places situated at Chatteris, March, Whittlesey indicated on maps for the purpose of identification only, prepared by the Council for that purpose, copies of which are available for inspection at the offices of the Council;
 - "sell" and "sale" include exposing and exposure for sale;
 - "Stall" includes any structure, standing bench, table, place or space used or intended to be used for the display or sale of goods.
 - "vehicle" means a motor vehicle as defined in Section 136(1) of the Road Traffic Regulation Act 1984.

Regulation of traffic and prevention of obstruction

- 2. No person in charge of a vehicle shall allow it to be halted in the market place, or in the immediate approaches thereto, for longer than is reasonable necessary for the unloading of goods.
- 3. No person shall bring into the market place or the immediate approaches thereto, or allow to stand therein, any vehicle, goods or receptacle for goods in such a manner as to cause an obstruction: Provided that this byelaw shall not apply to any vehicle being used for fire brigade, ambulance, police refuse disposal purposes in pursuance of statutory purposes.
- 4. No person driving or riding any vehicle in the market place or in the immediate approaches thereto shall proceed at a greater speed than 10 miles an hour.
- No tenant or occupier of a stall shall cause or permit any goods or any receptacle for goods to be placed on any stall so as to project beyond the limits of such stall.
- 6. No tenant or occupier of a stall shall display, stack or hang any goods on or from such stall at a height exceeding 3 metres.
- 7. No person shall bring any goods into the market place more than one and a half hours before the market opens or allow them to remain there more than half an hour after the market closes.
- 8. No person shall intentionally obstruct, disturb or hinder any person in the proper use of the market place or any of the fittings or apparatus proved for use therein or of the immediate approaches to the market place.

Authority to use space

- 9. No person shall occupy or take possession of any stall or deposit or cause to be deposited any goods, equipment or utensils on any stalls unless and until such stall has been duly let or otherwise allocated by the Market Officer and such letting or allocation has been confirmed in writing by him.
- 10. Where the Council:-
 - delegates any part of the market place for the sale of goods or for sale by auction, and
 - displays in a conspicuous place a public notice to that effect, no person shall sell goods or hold sales by auction except in accordance with the terms of that designation.
- 11. No person shall erect or fix or start to erect or fix any stall in the market place without the previous written consent of the Market Officer.
- 12. Every tenant or occupier of a stall shall cause his name to be painted clearly and legibly in uniform letters at least 38mm high on a board in a prominent position on the stall.

For maintaining cleanliness

- 13. Every tenant or occupier of a stall shall:
 - a. cause the stall to be properly cleaned before and after market hours and as often as may be necessary during those hours;
 - b. cause all refuse from the stall and all refuse arising from the loading and unloading of goods required in connection with the stall to be placed in a receptacle approved by the Council and shall, no later than one hour after the market closes, cause the contents of such receptacle to be promptly removed in such manner and with such precautions as not to create a nuisance in the process of removal from the market place.

For preservation of order

- 14. No person shall intentionally or negligently throw, drop or leave any fruit or vegetable matter or any other litter in or upon any avenue, roadway or passageway in the market place or in the immediate approaches thereto in a manner likely to cause injury to any person;
 - Provided that those byelaw shall not apply in respect of any place in the open air to which the Litter Act 1983, applies.
- 15. No person shall, to the annoyance of any other person, ring any bell or blow any horn, operate any record player, radio or cassette recorder or use any other noisy instrument or loudspeaker to attract attention or custom of any person to any sale or to any goods in or on any part of the market place.
- 16. No person, other than an officer or servant of the Council acting in the proper execution of his duty, shall post or display any bill, placard or poster other than a description of goods in or any part of the market place:
 - Provided that this byelaw shall not apply to any bill, placard or poster being posted or displayed pursuant of the Food Safety Act 1990.
- 17. Unless the written consent of the Market Officer be first obtained no person in the market place shall, except by way of sale, distribute to the public in the market place any printed matter,
- 18. No person shall, to the danger of any person, light a fire in any part of the market place.

Explosives

19. No person shall, to the danger of any person, keep, store or sell any gunpowder, fireworks, or other explosive substance or any naptha, bottled gas, petroleum or paraffin oil and other flammable substances in the market place.

Use of water taps

20. Every person who shall use any water tap in the market place shall cause the same to be properly turned off immediately after he shall have finished using such tap.

Animals

- 21. No person shall bring into or allow to remain in the market place any animal belonging to him or in his charge unless it is attached to a lead and kept at all times under his control or is otherwise kept sufficiently secured and under his control.
- 22. No tenant or occupier of a stall shall keep any dog or animal at his stall:

Provided that nothing in this byelaw shall prevent a blind person from bringing into the market place and keeping with him any guide dog belonging to him or in his charge.

Penalties

- 23. Every person who shall offend against any of these byelaws shall be liable on summary conviction to a fine not exceeding level 2 on the standard scale.
- 24. The byelaws made by Fenland District Council with respect to the general retail markets at Chatteris, March and Whittlesey on the 8th day of April 1981 and confirmed by the Secretary of State for the Environment on 22nd June, 1981 are hereby revoked.

Rule Number 6	All traders' vehicles (other than a unit solely intended for the display or sale of goods) must be removed immediately after they have been unloaded unless express permission for siting a vehicle on the Market Place has been given by the Authorised Officer in advance. All vehicles used by traders will be issued with a permit which must be displayed when unloading/and or parking.
Rule Number 7	No person shall be permitted to use more than one pitch in the Market on the same day except with the prior consent of an Authorised Officer.
Rule Number 8	Market Tolls shall be calculated by measuring actual space occupied by the stall. For the purpose of measuring the area occupied by a stall there shall be included in the area of the stall the ground immediately below its roof (if any). Provided that nothing in this Regulation is to be deemed to authorise the placing of goods on the ground or the hanging of goods from the stall or elsewhere so as to obstruct or prevent the passage of pedestrians between stalls.
Rule Number 9	Casual traders - Market tolls collected in cash shall be payable on Market Days on demand to the Authorised Officer. Tolls applied are listed on our website and are detailed in our main fees and charges. Where arrears remain outstanding after 1 month a formal Sundry Debtor will be raised and the trader will not be permitted to trade on the market until this has been paid. Licenced traders - Any arrears are notified to the Markets Manager who will make a formal request for payment in writing. Where arrears remain outstanding after 2 months a formal Sundry Debtor will be raised and 4 weeks' notice will be given to terminate any licence.
Rule Number 10	A Licensee may elect to pay monthly in advance by direct debit. Any trader so electing shall be allowed discount subject to there being no refund for any weeks of nonattendance unless evidence is provided that there were acceptable grounds to explain such non-attendance in which circumstances the Council may at its discretion choose to allow a pro-rata refund provided that this discount provision shall not apply during funfair weeks and if a trader has at his own request been allocated a pitch during that period, they shall be required to pay the normal toll. The discount applying to any month will be cancelled if payment is not made within 7 days of the due date. Monthly market tolls charged include a 6.5% discount if paid by direct debit for the whole year. (payable over 10 months 1 st April – 1 st January)
Rule Number 11	Licensees should, unless prevented by a good reason, inform the Authorised Officer beforehand of their intention not to stand on any particular day or when annual holidays are taken.
Rule Number 12	In the event of non-attendance of a licensee who pays tolls on a weekly basis, a 50 percent rebate of toll will be allowed providing that the Authorised Officer is informed by 4.00 pm on the day prior to the Market to which it relates.
Rule Number 13	A licensee's pitch shall only be held until 8.30 am on Market days unless the Market Officer has been requested to exceptionally reserve the pitch. After that time the Market Officer may re-allocate the pitch to any waiting casual trader not trading in the same line who must off-load and remove any vehicle from the Market within one hour of the allocation of the pitch (see also Regulations 6 and 20).
Rule Number 14	If a pitch is not occupied for a period of three consecutive weeks in any year it may no longer be reserved unless notice in writing has been given to the Authorised Officer giving adequate reasons for such absence, in which case it may at the discretion of the Markets Manager, be reserved for a longer period. Otherwise, it shall be considered vacant, available for re-letting, but any outstanding tolls due will be payable to the Council.
Rule Number 15	Any Licensee wishing to give up his pitch shall give one month's notice in writing to the Markets Manager and the Council reserves the right to give one month's notice to

terminate the arrangement between it and the Licensee. On such termination the Council will repay to the Licensee a proportionate part of any avdance payment made by him. Rule Number 16 Officer. Casual Traders			
Rule Number 30	Unless agreement has been reached before Market day with the Markets Manager regarding the occupancy of a vacant licensee's pitch, any vacancies may be let providing that the goods offered differ from that normally sold on that pitch. If there is a casual trader waiting for an unoccupied casual pitch, preference will be given to any trader or traders whose goods are different from any regular trader on the Market that day.

Sickness and Compassionate Leave			
Rule Number 35	Licensed traders that are sick must provide a doctors certificate at their own expense if they wish to claim exemption from Markets Tolls (self-certification is not acceptable) The council will allow tolls to be waived for an initial period of up to 4 weeks and will reserve the Traders regular pitch. Certificates will be required to cover the entire period if tolls are to be waived. In exceptional circumstances the period of tolls waived may be extended to 26 weeks.		
Rule Number 36	Any licensed trader may apply for compassionate leave on any trading day during the financial year at any market. This request must be confirmed din writing, giving reason for the application within 87 days of absence. The Markets Manager will approve the		

	cancellation of tolls due providing the application relates to a close family member or business partner,
Miscellaneous	
Rule Number 37	All stallholders, whether Casual Traders or Licensees, shall be subject to the Council's Disciplinary Code for Markets (The Code of Conduct). This code applies to all aspects of the traders conduct whilst on the Market Place. A copy of this code is issued to all new traders and immediately in the event of any breach of the Market Regulations or Market Byelaws. Any reference within the Market licence, Market Byelaws or Market Regulations to an Act of Parliament or regulation shall refer to that Act or regulation as it applies and any later amendment.
