## **Changes to Council Tax discounts**

In accordance with Section 11 (as amended) of the Local Government Finance Act 1992.

the Council has amended discounts in respect of certain types of properties from 1 April 2013.

These are shown below.

For unoccupied and unfurnished properties a 0% discount will apply.

For properties requiring /undergoing major structural work a 0% discount will apply.

For both above classes of property, an additional premium of 50% Council Tax will be charged from a date two years after the property first became empty.

For Holiday homes a 10% discount will apply. For Second Homes a 0% discount will apply.
