1. Status of the SHELAA (Stage 1)

- 1.1. Fenland District Council (FDC / the Council) has commenced preparation of a <u>new Local Plan</u> for the district. This new Local Plan will identify sites to meet Fenland's strategic development needs by making site allocations and/or identifying broad locations for growth.
- 1.2. The Council consulted on an 'Issues and Options' document between 11 October and 21 November 2019. As part of the Issues and Options consultation, the Council ran a Call for Sites exercise.
- 1.3. The Call for Sites exercise provided landowners, agents, developers, and other bodies with an interest in land, opportunity to submit sites for the Council to consider for inclusion in its Local Plan.
- 1.4. Most sites included in this SHELAA (stage 1) (*Strategic Housing & Economic Land Availability Assessment*) report were submitted to the Council in response to the Call for Sites exercise, indicating those sites are **available** for development.
- 1.5. The Council has decided to publish this SHELAA (stage 1) report for the purposes of openness and transparency. This report provides a comprehensive summary of all sites which will be subject to the site assessment process. The main purpose of this report is to allow the public, developers, service providers, parish & town councils and other organisations opportunity to view the sites which the Council received during the Call for Sites exercise and which it will subject to the rigorous site assessment process.
- 1.6. At this stage, no assessment has been carried out to determine each site's suitability for development or allocation in the emerging Local Plan. Inclusion of a site in this report does not provide the site any additional planning status or merit.
- 1.7. The Council is not consulting on or inviting comments on sites at this stage. Opportunity to make representations on individual sites will be provided during consultation on the draft Local Plan (scheduled to be held in summer 2020).
- 1.8. The Council will only allocate a site where it is suitable and available for development and is deliverable. Sites which are not suitable, available or deliverable will not be allocated. The Council's methodology for assessing sites is set out in the Site Assessment Methodology Report (October 2019)¹ and summarised below at Section 3.13.
- 1.9. A SHELAA (stage 2) report will be published alongside the draft Local Plan. The stage 2 report will summarise the findings from the site assessment process, and will draw conclusions on whether each site is suitable, available and deliverable.

2. Document Structure

- 2.1. This SHELAA (stage 1) report is structured as follows:
 - Section 1 explains the status of this report, to make it clear that sites do not benefit from additional planning status or merit as a result of being included in the report;
 - Section 2 sets out document structure;
 - Section 3 explains the background and context of sites listed in this report and the role and purpose of the SHELAA;

 - Section 5 provides an index and 'Site Reports' for each individual site;
 - Appendix 1 maps showing submitted sites in each settlement.

3. Background and Context

Purpose of SHELAA

3.1. A key purpose of the SHELAA is to help the Council understand what land is *available* for development within its district. At para. 67, the National Planning Policy Framework (NPPF) explains:

"Strategic policy-making authorities should have a clear understanding of the land available in their area through the preparation of a strategic housing land availability assessment..."

NPPF, Para. 67

3.2. The NPPF (para. 67) continues, highlighting the important role of the SHELAA in informing the preparation of Local Plans.

"...From this, planning policies should identify a sufficient supply and mix of sites, taking into account their availability, suitability and likely economic viability."

NPPF, Para. 67

3.3. The Council has commenced preparation of a new Local Plan for the district. The SHELAA will inform the preparation of this new Local Plan. The SHELAA will provide the Council with evidence of each site's suitability, availability and deliverability, enabling the Local Plan to identify a supply of sites to meet the district's development needs.

Source of sites

- 3.4. As discussed in section 1, the Council held a Call for Sites exercise in October and November 2019. The purpose of the Call for Sites was to invite submissions of sites which are available for development. Site submissions were received proposing a range of land uses and development types, for example, new housing development, employment, and other uses such as retail, leisure and pitches for Gypsies & Travellers.
- 3.5. All sites received during the Call for Sites exercise are set out in this SHELAA (stage 1) report, and will be assessed as per the process explained in the Site Assessment Methodology (October 2019). At this stage, site submissions received during the Call for Sites have not been assessed to determine their suitability for development.
- 3.6. To ensure the process of making a site submission was straight forward and accessible, site promoters were encouraged to complete a simple form, titled *Form B: Site Submission Form*², or via on online form on the Council's website.
- 3.7. In addition, this SHELAA (stage 1) report includes other sites known to the Council, which the Council understands to be available for development. These include:

- Undeveloped Local Plan 2014 allocations and broad locations for growth;
- Sites with planning permission (or resolution to grant planning permission) for housing developments of 5 or more dwellings; and
- Sites with planning permission for employment development (B-uses) with a site area of 0.15 ha or more.
- 3.8. Table 1 shows the number of sites by source. As illustrated in the table, most sites contained in this SHELAA (stage 1) report were received as site submissions during the Call for Sites exercise.

Explanation of two-stage process

3.9. The Planning Practice Guidance (PPG) which accompanies the NPPF describes further the scope and purpose of the SHELAA.

"An assessment of land availability identifies a future supply of land which is suitable, available and achievable for housing and economic development uses over the plan period. The assessment is an important source of evidence to inform plan-making and decision-taking, and the identification of a 5-year supply of housing land."

- 3.10. At this time, the Council has not assessed any sites to determine their suitability for development. However, as discussed in section 1, the Council is keen to be open and transparent about the sites it is considering for inclusion in the emerging Local Plan.
- 3.11. The Council will therefore publish the SHELAA in two stages. This stage 1 report includes no information on a site's suitability for development. This report provides a simple summary of sites the Council understands to be *available* for development, and which it will be taking forward for assessment. As such, including a site in this report does not provide the site with any additional planning status or merit.
 - 3.12. Following publication of this stage 1 report, the Council will commence the assessment of sites necessary to produce the 'stage 2' SHELAA report, applying the methodology set out in the <u>Site Assessment Methodology Report</u> (October 2019)³.

- 3.13. In summary, assessment of sites will include the following stages:
 - I. **Data collection** To inform the site assessment process, data will be collected using a range of methods, including:
 - a) Desktop analysis of sites using data already held by the Council or available in the public domain;
 - b) A 'Technical Consultation' through which service providers and public bodies will be invited to comment on each site;
 - c) A 'Parish Council Consultation', inviting town and parish councils to:
 - comment on each site suggested in their parish;
 - indicate whether they support the site (or not); and
 - rank each site in terms of preference.
 - d) New and updated evidence base studies prepared and commissioned by the Council.
 - e) Site visits to collect information about each site's features and to improve understanding of the local context.
 - II. Scoring and analysis— Using the data collected, each site will be scored against a number of 'major' and 'minor' assessment criteria as set out in section 4 of the <u>Site Methodology</u> <u>Report</u> (October 2019).

For consistency, the assessment criteria will be scored using a five point matrix. A sites' score against the criteria will be represented by both a colour and a letter. (Note that the letter and colour have the same value). The use of colour will provide a fair and consistent comparison for a single topic across all sites and also gives the reader an initial clear visual understanding of how a site has scored

III. **Sustainability Appraisal** – the Council will subject all site submissions to a process of sustainability appraisal, in part utilising the scoring and analysis described in Part II. For full details of the Sustainability Objectives, see the <u>Sustainability Appraisal Scoping</u>⁴ Report.

The Sustainability Appraisal is iterative and will be re-visited at each stage of preparing the Local Plan.

IV. **Site Selection and Evaluation** – the Council will review the results of the site assessment, findings of the Sustainability Appraisal and other evidence base documents, to identify a range of 'growth options'.

Where a site conflicts with one or more of the major criteria, it will be considered not suitable for allocation and will be rejected from the site assessment process and will not be allocated in the emerging Local Plan.

The various options identified through the evaluation process will be subject to Sustainability Appraisal, the results of which will inform the Council's selection of its preferred option.

3.14. The 'stage 2' SHELAA report will be published alongside the draft Local Plan, and will contain a summary of the findings of the site assessment process, drawing conclusions on a site's suitability for development. The stage 2 report will therefore be a 'complete' SHELAA, fulfilling the requirements of the PPG.

4. How to use the Site Reports

- 4.1. Section 5 contains an individual site report for each site submission including sites received through the Call for Sites exercises, and existing site allocations and sites with planning approval.
- 4.2. Site reports are arranged alphabetically by parish. Within each settlement 'chapter', site reports are arranged alphabetically by settlement. Note that where a site is distinctly separate from a settlement, it is listed as being located in the 'open countryside'. An index of site reports is provided in Section 5.
- 4.3. There are some instances of sites which adjoin a settlement, but are located in an adjacent parish. For example, adjoining the village of Benwick but located in the neighbouring Doddington parish. Sites are listed by the parish the site is located wholly, or mainly, in. It may therefore be helpful to refer to the settlement maps in Appendix 1, or the interactive SHELAA map on Fenland District Council's website.

Site Report Fields

- 4.4. Each report follows an identical format. To aid understanding of the site reports, Table 2 explains the content and data source of each report field.
- 4.5. It is important to note that most of the information presented in the Site Reports has been sourced from Site Submission Forms submitted by site promoters during the Call for Sites exercise. The information presented is that supplied by the site promoter, not the Council. The information shown in the site reports does not, therefore, constitute the views of the Council.

- 5.3. There are some instances of sites which adjoin a settlement, but are located in an adjacent parish. Sites are listed by the parish the site is located wholly, or mainly, in. It may therefore be helpful to refer to the settlement maps in Appendix 1, or the interactive SHELAA map on Fenland District Council's website to locate sites by settlement.
