The above payments have been made in accordance with the Council's Members' Allowances Scheme that came into effect, as a result of a review undertaken by an Independent Remuneration Panel on 4 November 2019. The revised scheme was introduced on 1 April 2020. The new allowances for 2021/22 are detailed in the table below, which have been amended in accordance with a review undertaken by an Independent Remuneration Panel on 19 May 2021 and backdated to 1 April 2021. A copy of the current scheme is available from the address below and on the Council's website (contained at Part 6 of the Constitution) at www.fenland.gov.uk.

The scheme provides for a Basic Allowance that is payable equally to all members (of £4,950 in 2020/21 and of £4,957 in 2021/22) and Special Responsibility Allowances (SRAs) payable to the holders of certain positions within the Council, subject to an increase in line with the employee pay award. Listed below are the posts that currently attract SRAs together with the respective level of allowances payable in 2020/21 and the corresponding allowances for 2021/22.

In addition, travelling and subsistence (where applicable) allowances are payable (at the rates of 45p, 24p and 20p per mile for motor vehicle, motor cycle and cycle respectively) for journeys undertaken by members in carrying out approved duties on behalf of the Council (as defined within the Members' Allowances Scheme).
