b) The prevention of crime and disorder	CCTV has been installed around the premises. We have a capacity limit that will not exceed 500 at any one time. We have a proof of age policy formulated in a discussion with the licensing authority. Crime prevention notices are displayed. All staff are trained to notice anybody in distress and fall a victim of a criminal activity.
c) Public safety	Fire - We have conducted a suitable fire risk assessment at the premises and implemented the necessary control measures. Records of these checks are kept on the premises. Disability - There is a toilet and also ramps to support disabled people. First aid - Adequate and appropriate first aid equipment is available on the premises with at least one staff trained and will be on duty at all times. There are health and safety signs inside the premises e.g. No smoking, support signs etc..
d) The prevention of public nuisance	All doors and windows will be shut past the time of 23:00 on any day to reduce the noise complaint. Amplified music will be reduced after 23:00 on any day. We have support signs inside to explain to our customers regarding noise control and to respect our neighbours. If anybody refuses to respect our policy and rules, they will be asked to leave the premises immediately.
e) The protection of children from harm	Children under 18 will not be allowed inside and outside the pub if the event is not age-appropriate. Children under 16 must be always accompanied by an adult 18+.
