# **Summary**

This report summarises the key findings from the public consultation survey regarding the Wisbech Regeneration Plan as part of the ongoing Pride in Place Town Board work.

Each question is analysed individually, followed by an overall summary of the results. Charts are included for clarity.

This consultation was undertaken online from the 3<sup>rd</sup> to the 19<sup>th</sup> of November in 2025.

The consultation was undertaken by Wisbech Town Board and delivered by Fenland District Council across various digital platforms.







**Q5:** Wardens form a key part of our ongoing engagement with the public and our target of reducing antisocial behaviour. Where in the town centre do you feel warden presence is most required? (Open Question)

#### **Results Summary:**

#### 1. Most Frequently Mentioned Locations

- o **Market Place / Market Square –** by far the most common response.
- St Peter's Church Gardens / Church Grounds repeatedly highlighted as a hotspot.
- o **Norfolk Street** often linked to drug dealing and antisocial behaviour.
- Wisbech Park especially evenings and after dark.
- o **Horsefair Shopping Centre / Bus Station –** cited as problematic areas.
- Museum Square / Crescent mentioned several times.

#### 2. General Coverage

- o Many respondents said <u>"everywhere"</u> or <u>"all over town centre"</u>, reflecting a perception that antisocial behaviour is widespread.
- o Some suggested flexible/mobile patrols to avoid simply displacing issues.

#### 3. Specific Issues Raised


- o Street drinking, drug use, and intimidation in public spaces.
- o Illegal parking and misuse of pedestrian areas.
- o Groups congregating near benches, car parks, and green spaces.

#### 4. Alternative Views

- o A notable minority argued wardens are ineffective and called for:
  - More police presence instead of wardens.
  - Investment in CCTV and lighting rather than personnel.
- A few respondents opposed wardens entirely, citing cost concerns.




**Q8:** You said more local jobs and business support are needed. We plan to offer small business grants and develop new small industrial units. These initiatives will help create and sustain local employment.













#### **Results Summary**

#### 1. Safety and Crime

- Concerns about drug dealing, street drinking, and intimidation in public spaces.
- Suggestions for CCTV expansion, better lighting, and enforcement of alcohol bans.

#### 2. Transport and Connectivity

- o Rail link restoration repeatedly cited as critical for regeneration.
- Calls for better road maintenance, addressing potholes, and improving A47/A1101 routes.
- o Parking issues: illegal parking enforcement and maintaining free parking.

#### 3. Town Centre and Economy

- o Desire for more shops, restaurants, and leisure facilities to attract visitors.
- o Reduce prevalence of charity shops, vape shops, and betting shops.
- Suggestions for lower business rates and incentives for independent businesses.

#### 4. Public Spaces and Heritage

- Support for heritage-led regeneration and restoring historic buildings.
- o Improve parks and riverside areas for social activities and tourism.
- Calls for cleaner streets, more bins, and better maintenance.

#### 5. Community and Inclusion

- Requests for greater transparency and accountability in decision-making.
- Ensure community involvement, including rural areas and youth engagement.
- Mixed views on diversity and inclusion—some supportive, others critical.

#### 6. Major Concerns

- o Incinerator project seen as a major threat to regeneration and health.
- o Scepticism about whether plans will be delivered or are "lip service."
- o Worries about antisocial behaviour overshadowing improvements.

## 4 - Interpretation of Findings

The Wisbech Regeneration Plan Public Consultation Survey paints a clear picture of both optimism and concern among residents and stakeholders. While the quantitative data shows strong support for the proposed initiatives and the Regeneration Plan, the qualitative responses reveal underlying issues about a broad spectrum of issues facing the town.

#### 1. Strong Support for Regeneration - But Conditional

Across the closed questions, agreement levels consistently exceed 75%, with some priorities—such as improving cleanliness (Q11) and enhancing public spaces (Q10)—reaching nearly 90% support. This suggests that the community broadly endorses the vision for a revitalised Wisbech. However, this support is not unconditional. Open-ended responses repeatedly stress that cosmetic improvements alone will not change perceptions unless deeper social issues are addressed. For example, respondents argue that "tidying and prettying up an area will not make it safer," highlighting that safety and enforcement are prerequisites for regeneration to succeed.

#### 2. Safety and Crime Dominate Public Concern

The most prominent theme in open responses is fear of crime and antisocial behaviour. Words like "unsafe," "intimidating," and "drug dealing" appear frequently. Many respondents describe avoiding the town centre altogether, particularly Norfolk Street and St Peter's Gardens, due to visible drinking, drug use, and groups congregating in public spaces. While CCTV and wardens are proposed as solutions, scepticism is high.

#### 3. Transport and Connectivity as a Catalyst

Another recurring theme though largely outside the scope of the Pride in Place programme is the urgent need for improved transport links, particularly the restoration of the rail connection and improvements to the A47 and A1101. The Council is working with the Cambridgeshire and Peterborough Combined Authority to address these strategic issues. Many respondents view this as the single most transformative intervention, enabling economic growth, attracting visitors, and reducing isolation. Parking enforcement and maintaining free parking are seen as essential to sustaining footfall in the town centre.

#### 4. Economic Revitalisation and Retail Mix

Respondents' express frustration with the current retail offer, dominated by charity shops, vape stores, and betting shops. There is strong demand for a more diverse mix of businesses, including restaurants, cafés, and independent retailers. Lowering business rates and offering incentives are suggested as ways to attract investment. Several comments link economic decline to social issues, arguing that without tackling crime and improving safety, businesses will not thrive regardless of financial incentives.

#### 5. Heritage and Public Spaces - Valued but Under Threat

Heritage emerges as a point of pride and a potential driver for tourism. However, respondents warn that neglect of historic buildings and poor maintenance undermines this strength. Calls for restoring Georgian architecture, improving shopfronts, and enhancing riverside areas are common. Parks and green spaces are seen as assets but currently perceived as unsafe due to antisocial behaviour.

#### 6. Major Challenges - Incinerator and Trust

The NSIP energy from waste (incinerator) scheme on the edge of the town has been highlighted by some respondents as a risk to regeneration efforts by damaging the town's image, health, and environment. However, as an approved development this falls outside the scope of the Pride in Place programme to influence.

There is also some scepticism about governance and delivery. Transparency measures, such as publishing Board minutes and ongoing communication, are welcomed and will be crucial to ensuring community support for the Programme.

### **5 - Conclusions**

The findings suggest that regeneration cannot be purely aesthetic or infrastructure led. Success depends on a **holistic approach** that prioritises:

- **Safety and enforcement** as the foundations for all other improvements.
- **Community engagement and trust-building**, ensuring transparency and visible progress.
- **Balanced investment** in heritage, public spaces, and retail diversity to create a vibrant, inclusive town centre.

Without addressing these core issues, even well-funded initiatives risk being perceived as superficial. Conversely, tackling crime, improving connectivity, and fostering genuine community involvement could transform Wisbech into a safer, more attractive, and economically resilient town.
