The above payments have been made in accordance with the Council's Members' Allowances Scheme that came into effect as a result of a review undertaken by an Independent Remuneration Panel on 11 December 2023. A copy of the current scheme is available on the Council's website (contained at Part 6 of the Constitution) at www.fenland.gov.uk.

The scheme provides for a Basic Allowance that is payable equally to all members (of £5,648 in 2024/25 and 2025/26) and Special Responsibility Allowances (SRAs) payable to the holders of certain positions within the Council, which are subject to an increase in line with the methodology agreed for any subsequent employee pay award as set out in the Constitution.
